What is this product?

Type

The product is a share class of the sub-fund Ethna SICAV - DEFENSIV A, which is part of the Ethna SICAV (the "umbrella fund"), an open-ended investment company with variable capital (société d'investissement à capital variable - SICAV) of the umbrella type governed by Part I of the Luxembourg Law of 17 December 2010, as amended (Law of 2010), and thus qualifies as a UCITS. The assets and liabilities of all sub-funds are segregated by law.

Term

The sub-fund has no maturity date. Notwithstanding this provision, the subfund, in keeping with the articles of association, may be dissolved at any time by resolution of the management board / general meeting.

Objectives

Investment objective

The investment objective of Ethna SICAV - DEFENSIV A ("sub-fund") is to mirror, as feeder UCITS, the performance of Ethna DEFENSIV (share class A) ("master UCITS"). The master UCITS is managed by ETHENEA Independent Investors S.A. The master UCITS is actively managed. The composition of the portfolio is determined by the fund manager solely in accordance with the criteria laid down in the investment objectives / the investment policy, is regularly reviewed and, if necessary, adjusted. The master UCITS is not managed using an index as a benchmark. DZ PRIVATBANK S.A. has been appointed as the depositary of the master UCITS.

Investment policy

The sub-fund permanently invests at least 85% of its net sub-fund assets in shares of the master UCITS. The sub-fund is therefore a feeder UCITS within the meaning of Article 77 of the Law of 17 December 2010. A maximum of 15% of the net sub-fund assets may be invested in liquid assets. The subfund may invest up to 100% of the net sub-fund assets in shares of the master UCITS. Financial instruments whose value depends on the future prices of other assets ("derivatives") may not be used for hedging purposes or to increase assets.

In its investment decision-making process, the master UCITS takes into account not only financial aspects but also environmental and social aspects and the principles of good corporate governance (Environment, Social, Governance - ESG) in accordance with the ESG strategy of the management company. Article 8 of Regulation (EU) 2019/2088 and Article 6 of Regulation (EU) 2020/852 (EU taxonomy) apply to this sub-fund. ETHENEA Independent Investors S.A. has signed the UN PRI (UNsupported Principles for Responsible Investment). Dividend policy

Income generated by this product is distributed to investors.

Subscription and redemption

Investors may, in principle, redeem their shares on any banking day in Luxembourg, with the exception of 24 and 31 December. The redemption of shares may, in due consideration of investors' interests, be suspended if this proves necessary in exceptional circumstances.

Intended retail investor

The fund is aimed at all types of investors who pursue the goal of asset accumulation or asset optimisation and wish to invest in the medium to long term. They should be able to bear losses up to the amount of the capital invested. The fund shall promote environmental and/or social characteristics in accordance with Article 8 of Regulation (EU) 2019/2088.



What are the risks and what could I get in return?



The risk indicator is based on the assumption that you will hold the product for 5 years.

If you cash in the investment early, the actual risk may differ significantly and you may get back less.

The stress scenario shows what you might get back in extreme market circumstances.

What happens if ETHENEA Independent Investors S.A. is unable to pay out?

The default of ETHENEA Independent Investors S.A. has no direct impact on your payout, as the statutory regulation provides that in the event of the insolvency of ETHENEA Independent Investors S.A., the special assets do not become part of the insolvency estate, but are maintained independently.

What are the costs?

How long should I hold it and can I take money out early?

Due to the risk and return profile, we recommend a holding period of at least 5 years for this product.
